Fall Service Modifications and Implementing Phase One of the Bus Network Improvement Project (BNIP)

BNIP First Round of Local Bus Schedule Overhauls: Line Nos. 3 and 19 have completely rebuilt weekday schedules.

New schedules for Local Bus Line Nos: 1, 3, 4, 5, 7, 8, 10, 13, 15, 17, 19, 20, 22, 23, 24, 27, 33, 36, 40, 44, 51, 52, 53, 54, 61, 64, 77, and 91.

The Bus Network Improvement Project (BNIP) launched in summer 2013 and will deliver meaningful and substantive improvements to MTA's Local Bus system. Phase One (starting August 2014 through 2015) of the Bus Network Improvement Project (BNIP) focuses on improving:

- 1. **Reliability** through enhanced on-street monitoring processes and bus schedule overhauls.
- 2. **Efficiency** by launching the Bus Stop Optimization pilot program on four Local Bus lines, Nos. 50, 53, 56, and 59 (complete details are listed in this notice).
- 3. **Real-Time Notification**, giving customers real-time bus information 24/7 (available this fall).
- 4. **Connections to New Job Centers** by improving transit access to the Horseshoe Casino and in 2015, to the Amazon Distribution Center.

Schedule Improvements

BNIP First Round of Local Bus Schedule Overhauls: Line Nos. 3 and 19 have completely rebuilt weekday schedules based on ridership and current traffic patterns. Weekend schedules will not change.

BNIP Connections to New Job Centers Service to the Baltimore Horseshoe Casino on Russell Street *Effective August 24, 2014*

- No. 51 Rogers Ave. Metro Subway Station to Patapsco Light Rail Station Modified service Northbound and Southbound between Washington Boulevard and Annapolis Road.
 - Northbound will operate via regular route to Russell St., Right onto Haines St., Left onto Warner St., Left onto Bayard St., Left onto Wicomico St., and then Right onto Monroe St. to continue the regular route. The bus stop closest to the casino is located on Haines St. at Warner St.
 - Southbound will operate via regular route to Monroe St., Left onto Wicomico St., Right onto Bush St., and then Right onto Russell St. to continue the regular route. The bus stop closest to the casino is located on Bush St. at Russell St.
 - Due to the change in southbound service from Monroe St. onto Wicomico St. the bus stop on Monroe St. at Wicomico St. will relocate to Wicomico St. just past Monroe St.
 - o No. 51 connects with
 - Metro Subway at Rogers Ave., West Cold Spring, and Mondawmin Stations.
 - Light Rail at Patapsco, Cherry Hill, and Westport Stations.
 - MARC Penn Line at West Baltimore MARC Station.
 - New connections on Haines St. to line No. 27 and the Greyhound Bus Terminal.

No. 27 – Reisterstown Plaza Metro Subway Station to Port Covington

Minor modification to Southbound service.

- Southbound will operate via regular route to Russell St., Left onto Haines St., service the Greyhound Bus Terminal, and then continue the regular route.
- Eliminate southbound bus stop on Bayard St. at Warner St.
- The bus stop closest to the Casino, Northbound and Southbound, is located on Haines St. at Warner St.
- o No. 27 connects with
 - Metro Subway at Reisterstown Plaza, Rogers Ave., and Lexington Market stations.
 - Light Rail at Cultural Center, Lexington Market, and Cherry Hill Stations.
 - Greyhound Bus Terminal on Haines St.

Coming in early 2015, service to the Amazon Distribution Center on Broening Highway will be provided by modifying service in the area.

BNIP Bus Stop Optimization Pilot Program

Adequately spacing bus stops helps to improve efficiency and travel time. Fewer bus stops results in faster service. MTA studied four Local Bus lines for this pilot program Nos: 50, 53, 56, and 59. Relocation and elimination to some bus stops on these four lines will also affect some bus stops shared with bus line Nos. 5, 5X, 18, 24, 44, and 97. BNIP Bus stop changes are proposed for implementation on or about October 13, 2014.
